This was a homeowner variance to install a permanent chain link fence in the front yard. Those voting felt that a variance was not appropriate for this situation because it was not unique to this address. This issue is widespread in Lake California. The sentiment was that it is more appropriate to wait for the Architectural Committee to complete their work on rule updates. The AC Committee is currently drafting a rule update that would allow certain types of styled chain link fences to be used. That rule change would also include specifics about what types and where those fences can be used. That rule update will go through the normal community review and comment cycle. Those voting No felt that process should be upheld.

The View from the Street

Below are ten things that every property owner and resident should know about owning property or residing here in Lake California.

1. Know the Rules - Understand and comply with the restrictive covenants, by-laws, and other rules and regulations of your property owners' association. These are often referred to as the CC&R's. Understand that each property owner made a covenant or "promise" with the association, (by the purchase of property within the common interest development) to make sure all the CC&Rs are abided by at the owner's property and all common areas within the community.
2. Know that you must pay your assessments on time whether these are property, reimbursement, enforcement, or facility rental assessments.
3. Know not to ignore communications from your property owners' association, especially notices that may be regarding outstanding assessments, rule violations, or fines. The Board of Directors has the responsibility to govern fairly and consistently in the interest of all members, which includes placing liens for nonpayment of assessments and fines. Do not let a minor issue escalate to the point where, what may have started out as a small matter leads to a much larger one with hundreds or even thousands of dollars in additional cost.
4. Know that your association has certain responsibilities to the membership including compliance with federal and state laws, fiduciary responsibility by Board of Directors members with regard to the collection of assessments, elections, meeting notices, meetings, due process, and much more as defined in the covenants and by-laws.
5. Know that if your property is a rental property or occupied by others, you must provide the association business office with a copy of any current rental agreement or documentation of any current occupants, and the tenants/occupants should understand that they must also comply with certain restrictive covenants such as use of the common areas, parking, pets, architectural changes, and other requirements. Know that the property owner is responsible for the actions and conduct of tenants, all occupants, pets, and any guests affiliated with their property.
6. Know that an Architectural Committee Application review and approval is generally required before making any alteration or improvement projects to the exterior of your property. This typically includes roofs, solar panels, sheds or detached garages, fences, above ground or in ground pools, exterior paint colors, door and window styles, landscaping, and driveways. Know that when your project is completed that you need to let your assigned committee member representative, or the association business office know.
7. Know to maintain a current mailing address, email address, and telephone number with the association business office. This is critical if you are a property owner that does not live in the community. (Examples include rental properties, second homes, investment properties, and homes used by children in college or retired parents.)
8. Know that you must maintain the condition of your property in accordance with the governing documents and rules.
9. Know who is in charge of running the daily affairs of the association and the contact information for the association business office.
10. Know to stay informed and participate in your property owners' association by reading the newsletters and meeting minutes, attending the monthly and annual meetings, understanding the budget, and volunteering to serve on committee or running for a position on the Board of Directors.

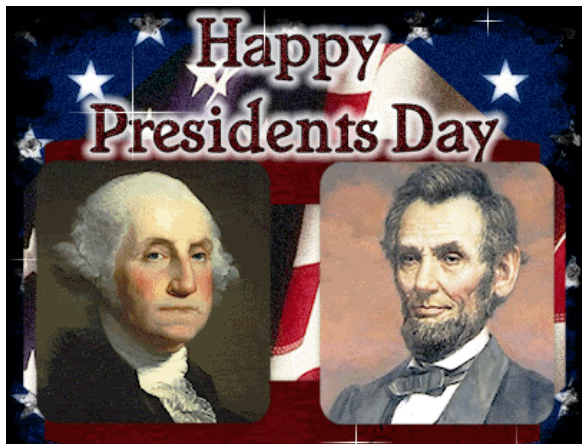

Hello Lake California,

We hope those that wanted to attend the crab feed got their tickets because as of this date we are official SOLD OUT. Thank you to those folks who purchased tickets. If you have not been to our signature event you are in for a treat. Our auxiliary staff have been working round the clock preparing for this day. Your donations will be used to purchase much needed equipment and supplies in order to give our community members the best possible care. This is an awesome community and I'm proud to be the leader of this fire company.

RESIDENTIAL NEWS:

The final tally of emergency calls we ran in 2022 was 366. We want our community to know our call volume is only going up and not once in the last 6 years has it dropped. That's up 31 calls from 2021. In 2017 our fire department ran only 265 calls in that year. In 5 years, that's an increase of 101 calls for service. Our point is we are only getting busier each year and it is vital to our community to sustain our volunteer firefighter program. Good news! Due to all the fire risk reduction work done by Lake California residents and the POA, Lake California has earned another Firewise Certification for 2023! This means that the National Fire Protection Association (NFPA) recognizes our community as one that works together to reduce fire risk. We work individually and collectively as part of the POA.

Congratulations – your renewal application has been approved!

The program's annual renewal criteria was met for this calendar year and the site has retained their "In Good Standing" status. Your site's wildfire risk reduction achievements contribute to making homes and firefighters safer when wildfires happen.

It also means that those of you who get a discount on your home insurance because we have the Firewise Certification can continue to get your discount. Just submit the new certificate which you can pick up at the POA office or download a copy from our website:

<https://lakecaliforniafirewise.wordpress.com/> If your home insurance hasn't offered a discount yet for Firewise certification, please call them and ask if they will now.

My home insurance has doubled since I bought my home 8 years ago and has been canceled by two different companies. For these reasons, I worked on getting the Firewise certification for our community. This certification has helped many Lake California residents save on their insurance and I'm hoping the list of insurance companies that work with Firewise will increase so we will all be included in the group who gets a discount. Companies that Firewise currently reports offer a discount: American Modern Home Insurance Company, USAA, ASI Select Insurance Corp, California Automobile Insurance Company, State Farm General Insurance Company, and the California FAIR Plan. May the list grow!

Along with this goal, Firewise has several ideas for this year and we hope that more community members will join to help make these things happen. We need more members to continue. Here are some of our goals for 2023:

1. Host a Firewise workshop for community residents
2. Present a two hour community workshop entitled "How To Have A Firewise Home."

3. Organize a community-wide wildfire hazard reduction workday. Designate a Saturday for a community wildfire hazard reduction event. The event can begin with a morning briefing, then residents spend the morning on hazard reduction projects at their home
4. Through social media and newsletter, publicize Firewise information.
5. Support the POAs efforts in paying for the goats and educate residents the importance of this investment through the newsletter and social media posts.
6. Share Firewise Certificate with residents through POA and the benefits of being a Firewise community.

The Program is intended to help Tehama County citizens 65+ years of age as well as those who are physically unable to create the required defensible space surrounding their home at no cost. Eligible properties must be located in Tehama County and designated within a State Responsibility Area (SRA) or Local Responsibility Area (LRA) or Wildland Urban Interface (WUI) zone. There's an online application to request help.

Billing Updates: Unpaid metered billings for the period 09/6/22 to 11/3/22 are scheduled for lock off on February 6, 2023. Current billings for the period 11/3/22 to 01/3/23 are due in the office by February 5, 2023 to avoid delinquent charges. Payments can be made by check or cash, and credit card payments can be made on our website at www.RAWD.org. Customers can also sign up for auto draft payments by completing the form found on our website or at the District office.

Drought: The recent storms have really boosted our precipitation totals for the current water year. The current statewide average snowpack is 226% of normal and Shasta Lake is up 57.76 feet since last reported. As of January 18th, we have already exceeded the total annual precipitation received in the 21/22 water year. Let's hope we continue with this pattern and don't stop here because we are still not out of the drought. The new totals beginning October 1st and comparisons are as follows:

Year	Jan. 18 Precipitation Received	Average Precipitation to Date	Percent of Average	Shasta Lake feet from Crest
22/23	20.04	15.30	131%	88.20
21/22	14.77	14.12	104%	140.64
20/21	5.62	15.46	36%	105.80

We are experiencing freezing temperatures, so please make every effort to wrap any exposed piping to protect your pipes from freezing and bursting. **Sprinklers should be shut off for the winter now.**

Wetlands Update: Over 150 people have purchased their key cards for the wetlands, and we hope this new system will provide a safer and more desirable experience while enjoying the wetlands. As a reminder, please do not allow entrance to anyone (that is not within your party) who does not possess a card. Contracts can be completed, and key cards purchased at the Rio Alto Water District Office (**not the POA office**). The \$10.00 nonrefundable deposit must be paid by check or cash. No cards can be accepted. Due to recent vandalism, a second camera is being installed.

Wastewater Treatment Plant Updates: The District would like to remind customers **not to flush anything down the toilet other than human waste and toilet paper**. This includes feminine hygiene products, diapers, paper towels, the new toilet cleaning (flushable) pads and baby wipes (**even if they state they are biodegradable**). Fats and oils from cooking should never be disposed of through home plumbing systems. Lateral plugs can be very costly to the homeowner and plugs can cause mechanical failures at our lift stations and wastewater treatment plant.

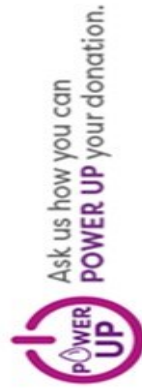

NOTICE

The Board of Directors has approved burning in Lake California for residents on their private property only. No burning shall take place by residents on LCPOA common areas or greenbelts. Burning may take place from January 1st, 2023 through May 1st, 2023 (burning could be suspended if needed due to changing weather conditions). Residents that wish to burn, on proper burn days, must obtain a burn permit from Cal-Fire. You may go online to obtain the permit (burnpermit.fire.ca.gov). As of May 2nd, 2023 burning will not be allowed by residents per rule RR-06-06 Burning.

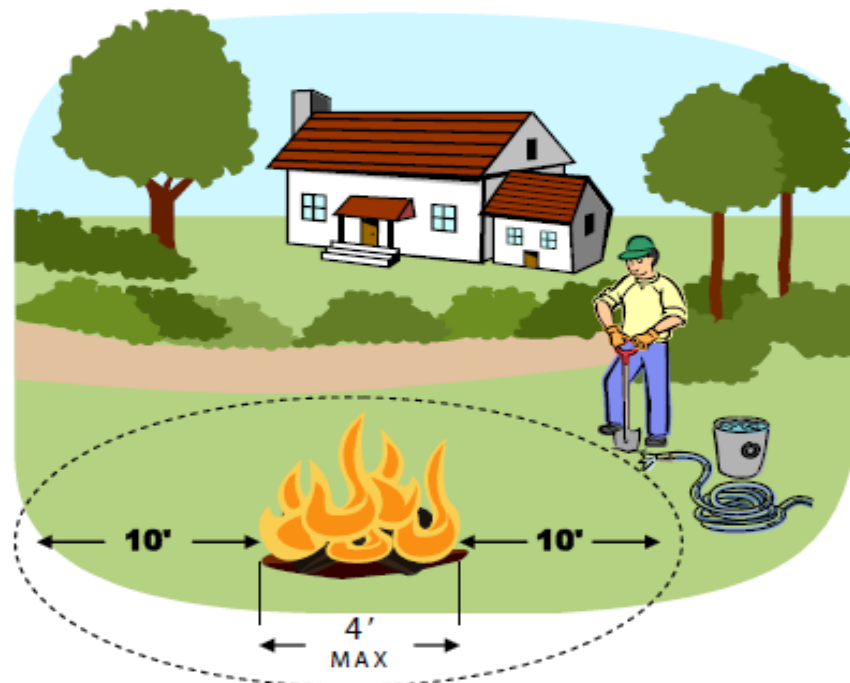

Debris Burning

The following are burning permit requirements:

For burning debris in small 4-foot x 4-foot piles:

- Maximum pile size 4 foot in diameter.
- Clear all flammable material and vegetation within 10-feet of the outer edge of pile.
- Keep a water supply close to the burning site.
- An adult should be in attendance with a shovel until the fire is out.
- No burning shall be undertaken unless weather conditions (particularly wind) are such that burning can be considered safe.



No household trash or garbage can be burned outdoors at residences. Dry, natural vegetation, grown on the property can still be burned outdoors in open piles, unless prohibited by local ordinances. Burning can only be done on permissive burn days. Burn permits are only valid on "Permissive Burn Days" as determined by the State Air Resources Board or the local Air Pollution Control District (APCD).

Violations Of Any Burning Permit Terms Are A Violation Of State Law
(Public Resources Code 4421, 4422, 4423 And 4425)

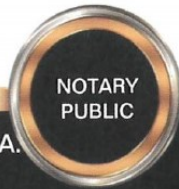





In contrast, only about 2,000 butterflies were counted across the state in the 2020 count.
