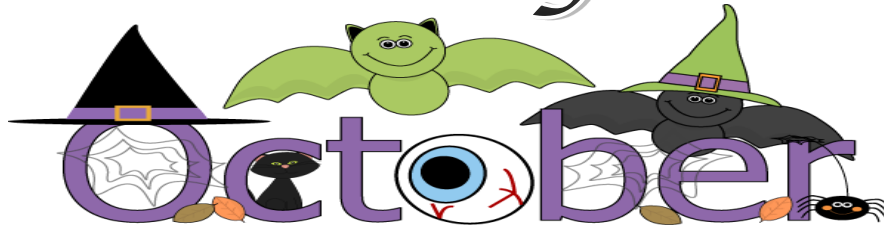

Construction of this hangar would be in violation of Code of Federal Regulations (CFR) 77 height restrictions at airports. If this variance is approved by the Board, a variance request form would be submitted by the LCPOA to the Aviation Branch of Cal Trans for their approval. The LCPOA is being asked to pay the County Transfer Tax of \$2.20, Homeowners Association fee of \$75, and Rio Alto Water Transfer fee of \$20. Buyers are aware of the additional Tract 1017 Improvement fee that would be paid to Tehama County if the lot is built on, along with any other building fees associated with building a lot within Lake California.



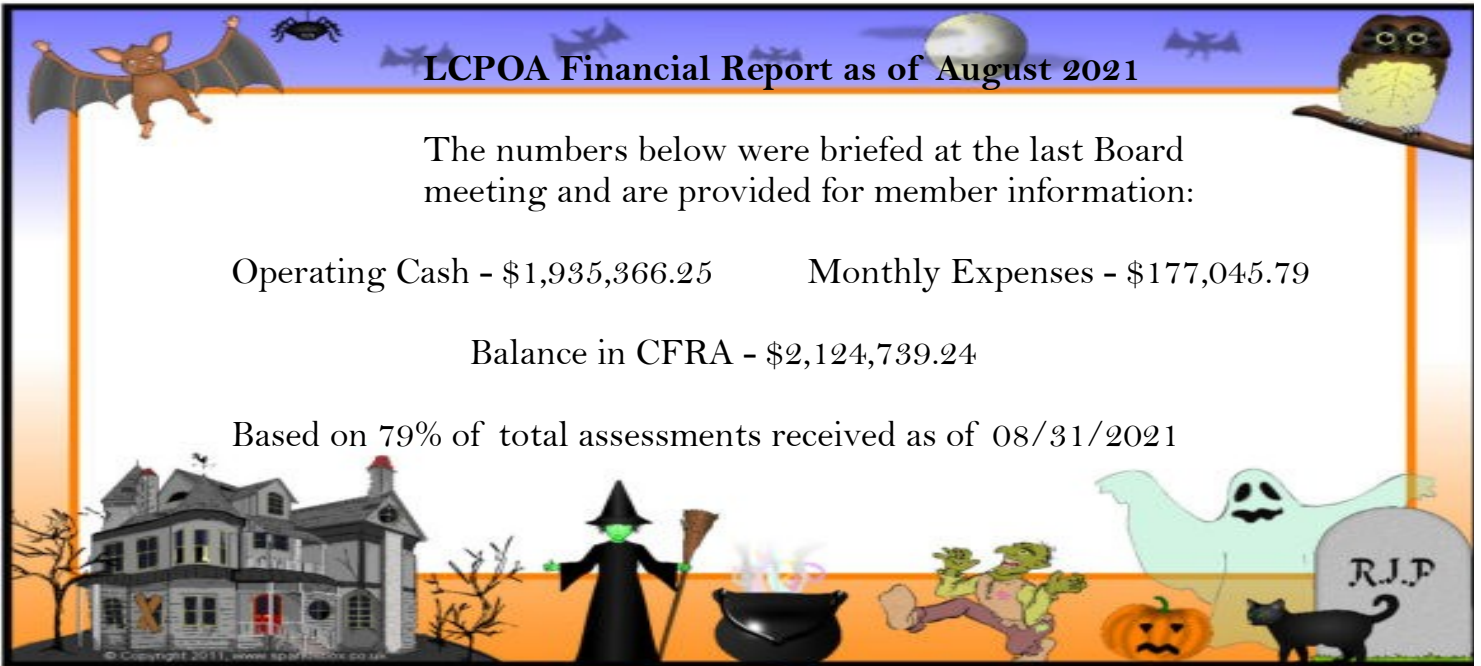

With all the issues with PG&E there has been an increase in Applications for Alteration and Additions for Solar Panels.

Before you start the process please complete an Application for Additions & Alterations. When you turn in your application we will want a copy of your solar plans and before the company can install we will need a copy of the Tehama County Permit as well as the Tehama County approved installation plans.

The Solar Company will do all the paperwork for the Tehama County Permit but most of them are not aware of our rules, process, and our paperwork.

To avoid any delays please contact our Member Services with any questions you may have. Remember there is a 5-7 day approval process.



IMPORTANT ANNOUNCEMENT

From time to time residents that live by the office may hear gun shots. The LCPOA has a Fish and Wildlife permit that allows us to shoot pigs. This normally happens in the hours of 10 PM to 3 AM when the pigs are out doing the most damage. Please do not be alarmed if you see someone during these hours with a rifle in hand near the office grounds.

FREE FIREWOOD – Bill’s Tree Service has started removing fallen and dead trees and will gradually make their way throughout the community greenbelts. Vacant lots will be used as access points throughout the community for this project. Authority for the LCPOA to enter vacant lots to access the greenbelts can be found under Article 7.2 of the Declaration of Restrictions. Notification of entry to property owners was announced in the June newsletter and was included in the June agenda minutes. **Please feel free to take any of the stacked firewood that will be left near the side of the street.** No further cutting/splitting is allowed on vacant lots.

The View from the Street

During the upcoming Community Yard Sale, the second weekend of this month the following are requirements for all participating community members.

- (1) Members must register with the LCPOA office to place yard sale signs within the community. **(This is a mandatory requirement.)**
- (2) Signs may be **placed no earlier** than the Friday prior to the Saturday event **and must be taken down** no later than the following Sunday.
- (3) Name, Address and Phone number **must be on the back of the sign.** **(Any signs found without this required information will be removed.)**
- (4) If signs are not removed by Monday after the Saturday event, a disciplinary fine may be imposed.
- (5) Members Family and Guest must be registered in your “Dwelling Live” account by 4 PM on Friday prior to the Saturday event, and Members Guests must be in the authorized member list and have a valid ID for entry.

We want to again remind all residents that the parking of any personal vehicles or equipment on any LCPOA common area property not designated for parking, (such as the open area property at the corner of River View Drive & Lake California Drive across from the airfield) without written authorization is prohibited. This is covered in the LCPOA Declaration Of Restrictions under **ARTICLE 8.3 USE OF COMMON AREA** which states in part that ***“nothing shall be altered, constructed, placed, kept, stored, parked, planted on, or removed from the Common Area without the prior written consent of the Board.”***

Also, as we start entering in and out of the various holiday seasons where outdoor decorations will be displayed, it’s a good time to remind property owners that community rule and regulation **RR-06-12 HOLIDAY DECORATIONS** requires that all holiday decorations must be removed from the front of the house within 30 days after the applicable holiday.

Please remember to keep your residential lawns & property easements all the way to the edge of any street that border your property cut and maintained in an attractive condition in accordance with **ARTICLE 7.4.1 Maintenance of Lots**; and that vehicles, trailers, and recreational equipment are kept parked in accordance with community rule **RR-06-20 PARKING**.

Storage of personal property should be stored so that items are not visible from the road as required by community rule **RR-06-23 STORAGE**.

Billing Updates: Metered billings for the period 07/02/21 – 09/02/21 were mailed out on 9/3/21 and will be due and payable by Oct. 7, 2021. Availability lot billings for the quarter 7/1/21 – 9/30/21 will be mailed out on Sept. 30, 2021, and will be due and payable by November Nov. 4, 2021. Payments can be made by check or cash, and credit card payments can be made on our website at www.RAWD.org. Customers can also sign up for auto draft payments by completing the form found on our website or at the District office.

Drought: The state water year begins October 1st every year. As of September 16, 2021, the season to date precipitation was 14.19 inches with the normal average season to date being 33.26 inches. We are currently 57.4% below the average. Lake Shasta level is 169.12 feet from the crest, down 13.47 feet from the level reported last month. At this time last year, the lake level was 95.95 feet from the crest and the year before that was 39.48 feet from the crest (Down 73.17 feet from last year and down 129.64 feet from the year before.) The snow water equivalents for August reported 0% for the entire state of California. This is not a promising report. Our water consumption was obviously up during the last billing period due to the seasonal temperatures, but we are still 17.38% below the consumption that was used in 2013. The days are growing shorter and night-time temperatures cooler, so now is the time to **reduce timers** to your outside irrigation systems. We currently remain on voluntary restrictions, but we all need to do our part. The District will notify its customers if this changes.

Sustainable Groundwater Management Act (SGMA): This District is an active member of the Tehama County Groundwater Sustainability Agency which is tasked with preparing a Groundwater Management Plan (GSP). The plan needs to assure the groundwater in Tehama County is sustainable for 50 years to come. Tehama County SGMA will be holding the following outreach meetings for those interested in learning more or who would like to review the plan:

Hello Lake California,

Mark your Calendars: October 9th between 0900-1400 hrs. our auxiliary staff will be selling Chili dogs and apparel again at the station during the annual neighborhood garage sale. This will be a takeout only event. We hope you come by and support the event. Come get a grilled chili dog, bag of chips and a cold drink for \$5.00. We sold out last April by 1300. We hope we have enough food to last to the end this time. Come early and don't miss out. All proceeds go to purchasing equipment and supplies, this directly benefits the community.

Last month we had 10 major fires burning around us, the Dixie, McFarland and Monument fires were the largest and closest. The Dixie fire is almost 100% contained while the others in the Trinity Alps will most likely burn until rain and snow falls. These fires are located in wilderness areas, very steep and inaccessible areas. We just came out of a RED FLAG situation, and we would like to thank the community for having no incidents during this time. The RED FLAG situation caused many of the local fires to spread rapidly. These fires exhibited extreme fire behavior and extreme rates of spread making suppression efforts very difficult. Summertime will be coming to an end soon and hopefully fire season. RAIN is what is needed now.

We had an engine assigned to the "August Preposition" assignment. Our engine was covering both Lake California and Bowman areas. The engine was available to travel anywhere in the county as needed. Unfortunately, both crew members contacted COVID and the engine was taken out of service due to sickness. COVID is real and is affecting many people in Lake California, the Cottonwood area and all the surrounding areas. We strongly recommend that you do what you think is right to combat the affects of COVID.

We currently have 8 new applications in progress, and we would like to thank those people who have stepped up to become a volunteer firefighter with us. We are very excited to have this many people in the process. This is your community and being a volunteer firefighter or Auxiliary member is a great way to give back to your community.

Training this past month was on the use of portable power equipment, portable radios, and report on conditions.

We would like to thank the many people who have donated to our organization. The money is used to purchase much needed supplies and equipment to better serve you. If everyone in our community sent in a single donation of \$10.00, we would be able to purchase so much more. All proceeds go directly back to you. Thank you in advance.

RESIDENTIAL PREPAREDNESS: Our community CERT team was able to secure funds from a grant and provide several new fire extinguishers for our community. We have teamed up with the CERT staff and we will be conducting community hands on fire extinguisher training on Sunday October 3th, 0900-1100 hrs. and again October 7th, 1800-2000 hrs. at our fire station.
